I have read, understand and agree to comply with and support the following camp policies. I understand that the following list of policies does not constitute the entire list of camp policies and behaviors that I or my child must comply with. I further understand that this agreement is a condition of enrolling my child and is an addendum to the Terms of Agreement of the Enrollment Application.

1. **PACKAGES** - In an interest in placing the emphasis in camp on activities, programs and friendships, we wish to eliminate the inevitable competition and disruption caused by the receipt of toys, water guns and the like. Books, magazines and stationary are fine to send as long as it is sent in a flat 9x12 envelope. You may not send food, gum, or candy of ANY kind to camp. We will not be accepting packages that are not in a FLAT envelope; all other packages will be refused and sent back to the shipper. We must reserve the right to check all incoming packages. Please help us by alerting all friends and relatives.
2. **CLOTHING** – Campers are provided an equal amount of storage space in the cabins. Bunk storage space is limited. The camp packing list should be complied with. Campers who bring excessive amounts of personal belongings will impinge on the space allocated to other campers, thus crowding the bunk. The camp may, at its discretion, determine what is excessive and, either return unnecessary items home or store them at the camp’s convenience.
3. **PHONE CALLS** – Each camper is entitled to two phone calls home each session they attend camp. There are specifically designated call days (see your parent handbook). Campers are allowed an additional phone call if there birthday falls within the time they are at camp. Each calls is approximately 8-10 minutes in length. We need 24 hours advance notice in order to change a scheduled phone call time and only if the new time can be accommodated within the camp call schedule.
4. **CELL PHONES** – Cell phones are **NEVER** permitted in camp or on camp trips regardless of your child’s age. The camp may, at it’s discretion, confiscate or hold cell phones or other similar devices and campers may be suspended or dismissed for bringing a cell phone to camp or using a cell phone at camp.
5. **ELECTRONIC EQUIPMENT** – No device capable of viewing DVD’s, videos (including iPods/ iPod touch), or emails are permitted in camp. Hand held electronic games, including games boys, PSP’s etc are no longer permitted. Campers are advised that they are both unnecessary and run counter to the social interactions that are the main goal of attending camp. The camp is not responsible for the damage, theft or other loss of any personal items, including digital cameras.
6. **RAID POLICY** - Campers are not permitted out of their cabin, unsupervised, either after curfew or before reveille. Campers found to be not in their beds or out of their cabin during that time will be considered “raiding”. Campers determined to have been “raiding” will be dismissed from camp without exception. There are absolutely NO REFUNDS whatsoever for dismissal from camp for “raiding”.
7. **CONTRABAND** – Campers who use or are in possession of any tobacco, alcohol or illegal substance will be immediately dismissed without exception. There are absolutely NO REFUNDS whatsoever for dismissal from camp for use or possession of contraband.

In the event that one parent executes this agreement, I acknowledge that I am also acting as agent of the other parent with authority to so and agree to its terms and execute this. Furthermore, I agree that I have discussed these policies with my child who is enrolled at camp. I recognize that the Camp relies upon the representations herein made in accepting my child’s enrollment in Camp.
